ARBITRAL AWARD

This matter was heard by the undersigned as an arbitrator on March 10, 2000. I find the following facts:

1. On May 11, 1997 at approximately 3:26 p.m., Plaintiff Omar K. Tibby was driving a 1986 Series 3 BMW owned by Doreen Chambers west on Albany Avenue, Hartford.

2. Plaintiff Robert Tibby (Plaintiff Omar Tibby's brother) was a passenger in the BMW.

3. Defendant Keisha Hernandez was driving east on Albany Avenue in a 1988 Honda owned by Defendant Shelly Hernandez.

4. Defendant Keisha Hernandez making a left turn onto Edgewood Street when she struck the BMW as it was overtaking another car (making a left turn) on the right.

5. Plaintiffs have been in a remarkable number of accidents since arriving in the United States (primarily on Albany Avenue) two years ago. Virtually each time,

Plaintiff Robert Tibby was a passenger in a car driven by Plaintiff Omar Tibby.

6. There is no doubt there was a significant impact in this case.

7. Plaintiff Omar Tibby incurred medical bills of \$278.00 to L&M Ambulance.

8. Plaintiff Omar Tibby incurred medical bills of \$472.54 to Saint Francis Hospital & Medical Center.

9. Plaintiff Omar Tibby incurred medical bills of \$57.00 to Radiology Associates of Hartford.

10. Plaintiff Omar Tibby incurred medical bills of \$160.00 to Nutmeg Medical.

11. Plaintiff Omar Tibby incurred medical bills of \$1,825.00 to Shaw Chiropractic.

12. Plaintiff Omar Tibby has incurred damages of \$8,487.70 because of Defendants' actions. This must be reduced by 20% for contributory negligence, resulting in final damages of \$6,790.16.

13. Plaintiff Robert Tibby incurred medical bills of \$278.00 to L&M Ambulance.

14. Plaintiff Robert Tibby incurred medical bills of \$1,604.01 to Saint Francis Hospital & Medical Center.

15. Plaintiff Robert Tibby incurred medical bills of \$416.00 to Radiology Associates of Hartford.

16. Plaintiff Omar Tibby incurred medical bills of \$160.00 to Nutmeg Medical.

17. Plaintiff Omar Tibby incurred medical bills of \$1,795.00 to Shaw Chiropractic.

18. Plaintiff Robert Tibby has incurred damages of \$13,180.05 because of Defendants' actions.
